Project Background

Purpose: The purpose of the project is to replace the Chapel Drive and Griggstown Causeway bridges over the D&R Canal, which are both in poor condition. During the Chapel Drive Bridge replacement, access will be maintained to the Pillar of Fire Campus. The Griggstown Causeway Bridge replacement will require a detour during construction.

Need: The Chapel Drive Bridge was built in 1951 and reconstructed in 1997. The Griggstown Causeway Bridge was built in 1950 and reconstructed in 1990. Due to the poor conditions of the substructures, both bridges require replacement to provide a safe and efficient bridge crossing.

Project: The proposed Chapel Drive Bridge will be a single-span steel plate girder bridge with plank decking. The proposed Griggstown Causeway Bridge will be a single-span steel plate girder bridge with a concrete deck and timber sidewalk surface.

Additional improvements include:

- Widening the bridges
- Raising the roadway profile
- Upgrading ADA-compliant sidewalk
- Install structural bridge railings
- Utility Relocation

- Install flashing beacon for trail crossing at Griggstown Causeway

Historic and Cultural Resources

State and federal regulations pertaining to the protection of historic properties, referred to as the Section 106 process, require NJDOT to take into account the effect of proposed projects upon historic resources listed in, or eligible for listing in, the National Register of Historic Places.
